Mayor Labbe moves that that City Council approve the Conditional Use Permit for PBVILLE LLC DBA Floyd's of Leadville (Floyd Landis, Scott Thompson) to transfer their retail marijuana retail store operation to 1101 Poplar Street All representations made by the applicant and relied upon by the Planning and Zoning Commission and/or the City Council in evaluating the Conditional Use Permit shall be deemed a part of the application and binding upon the applicant. Additionally, city council would condition that a six foot privacy fence be built along the Western most side of the property, and that the fence be installed with in 30 days, Furthermore, council requests that the two off street parking spots be clearly marked as Floyd's customer parking.
