## **Consensus amendments to Ordinance 6:**

- Insert a non-use clause that will state that, if a STR is not rented for at least 14 days during the previous application year, that STR license will not be considered for renewal in the next application year
- Owner occupied STRs that have three or more guest units will only count as 1 unit against the cap
- 5.12.080 A. add language stating that, if an existing STR licensee submits a completed STR application, and that licensee is in good standing, then their renewal will be issued.
- 5.12.090 K. change "perform an inspection" to "perform a safety check"
- 5.12.090 N. change the wording to say, "gatherings in excess of the maximum allowed occupancy for that STR unit are prohibited"
- 5.12.090 O. make sure that the wording matches the nuisance wording in Title 8 nuisance code
- 5.12.100 E. change "has been cited for or convicted of" to "has been found guilty of" to be consistent with 5.12.110 A.1

Mayor Labbe moved to adopt Ordinance 6, Series 2020, an ordinance amending Chapter 5.12 of Title 5 and various sections of Title 17 of the Leadville Municipal Code concerning short-term rentals on first reading with the above amendments. Labbe further moved to schedule second reading of the ordinance for city council's regular meeting on January 5, 2021, CM Green seconded, unanimous approval by council
