Ordinance 7, Series 2020, Chapter 3.08 Contract Purchasing Requirements, second reading –

CM Gowing moved to adopt Ordinance 8, Series 2020, an ordinance reenacting a temporary suspension of certain sign code requirements and declaring an emergency on first reading. Ordinance 9, Series 2020, extending parking permit program moratorium, first reading – CM Hill moved to adopt Ordinance 9, Series 2020, an ordinance extending the temporary moratorium on the city's issuance of parking permits and declaring an emergency on first reading. I further move to schedule second reading of this ordinance for city council's regular meeting on January 19, 2021, MPT Lauchner seconded, unanimous approval by council.

## Ordinance 10, Series 2020, approval of Ford lease-purchase agreement -

MPT Lauchner moved to adopt Ordinance 10, Series 2020, an ordinance authorizing the City of Leadville to enter into municipal lease-purchase agreement with Ford Motor Credit Company LLC., for the lease and purchase of three 2020 police interceptor utility vehicles for police purposes on first reading.
