A RESOLUTION AUTHORIZING THE CITY OF LEADVILLE TO ENTER INTO A GOVERNMENT OBLIGATION CONTRACT AND RELATED DOCUMENTATION WITH KS STATEBANK FOR THE LEASE AND PURCHASE OF ONE NEW 2021 MACK TRUCK FOR MUNICIPAL PURPOSES

WHEREAS, the City Council, as the governing body of the City of Leadville (the "City" or "Obligator") as determined that a true and very real need exists for the acquisition of the Equipment defined and described in the Government Obligation Contract (the "Government Obligation Contract") attached hereto as Exhibit A and presented at the November 4, 2020 City Council meeting; and

WHEREAS, the City Council has taken the necessary steps under applicable law to arrange for the acquisition and financing of such equipment; and

WHEREAS, the City Council has reviewed the form of the Government Obligation Contract and has found the terms and conditions thereof acceptable.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado as follows:

<u>Section 1</u>. <u>Determination of Need</u>. The City Council of the City of Leadville makes the following findings and representations:

- (a) A true and very real need exists for the acquisition of the Equipment defined and described in the Government Obligation Contract dated October 22, 2020, between the City of Leadville, Colorado and KS StateBank.
- (b) The Government Obligation Contract, substantially in the form attached to this Resolution, is in the best interest of the City for the acquisition of such Equipment.

Section 2. Approval and Authorization. The City Council, as governing body of Obligor, hereby approves the Government Obligation Contract and designates and confirms the Mayor has the authority to execute and deliver the Government Obligation Contract and any related documents including Escrow Agreement necessary to the consummation of the transactions contemplated by the Government Obligation Contract in substantially the form attached hereto as Exhibit A. The Mayor, in consultation with the City Attorney, may make such non-material changes to the Government Obligation Contract and related documents and certificates as such officers and officials deem necessary or desirable, such approval to be conclusively evidenced by

the execution and delivery thereof. The City Council further authorizes and direct City officials and staff to fulfill all obligations under the terms of the Government Obligation Contract.
