#### **Full Circle Youth Presentation -**

Members of Full Circle's Youth Action Squad presented their findings to city council from a survey they conducted the in the Fall of 2020. The Survey was in relation to the level of safety that Lake County residents feel in specific public spaces. The squad identified two specific areas where residents felt substantially less safe (The Skate Park and the Mineral Belt between the Intermediate School and Ice Palace Park). They made a couple of recommendations to city council and the police chief, which included better lighting on the Mineral Belt and increased patrolling of the Skate park.
