## I. REQUEST OR ISSUE:

Staff requests that council adopt Resolution 1, Series of 2023 a Resolution Designating the Official Public Notice Location and the Official Newspaper of General Circulation for the City of Leadville, Colorado.

## II. BACKGROUND INFORMATION:

Colorado Revised Statutes 24-6-401(2)(c) requires that the public place or places for posting notice of public meetings be designated annually at the local public body's first regular meeting of each calendar year. The city has traditionally posted notice of its public meetings (city council and commissions) on the front door of city hall, on the city's website and in the *Leadville Herald*.

## III. FISCAL IMPACTS:

There is no fiscal impact of this motion.

### IV. LEGAL ISSUES:

This motion is necessary to comply with Colorado Revised Statutes 24-6-401(2)(c).

# A RESOLUTION DESIGNATING THE OFFICIAL PUBLIC NOTICE LOCATION AND THE OFFICIAL NEWSPAPER OF GENERAL CIRCULATION FOR THE CITY OF LEADVILLE, COLORADO

- WHEREAS, C.R.S. § 24-6-402(2)(c) requires the annual designation of the City's official public posting location for notices of regular and special meetings; and
- WHEREAS, C.R.S. § 24-6-402(2)(c) also states that the Colorado General Assembly intends for local governments to transition from posting notices in physical locations to posting notices online to the greatest extent practicable so long as the online posting location requirements of state law are met; and
- **WHEREAS**, City Council believes that posting notices on the City's website is a more effective and accessible means of dissemination and provides more flexibility than the physical posting location; and
- WHEREAS, the City Council wishes to continue posting notices in a physical location to the extent practicable or when emergency circumstances exist such that posting on the website is not possible; and
- WHEREAS, the City of Leadville is also required by state law to publish certain notices in a newspaper of general circulation; and
- WHEREAS, City Council desires to designate the City's website as the official posting location, while continuing to post at its physical posting location when practicable or necessary, as well as designate its newspaper of general circulation for calendar year 2023.

# NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado, as follows:

- Section 1. The City of Leadville website, <a href="https://cityofleadville.colorado.gov">https://cityofleadville.colorado.gov</a>, is hereby designated as the place at which notices of regular and special meetings of City Council, meetings of City boards and commissions, and other public notices shall be posted for purposes of compliance with the Colorado Open Meetings Law, C.R.S. § 24-6-402(2)(c).
- Section 2. In exigent or emergency circumstances that prevent the City from posting a meeting notice or other public notice on the City's website, the following location is hereby designated as the place at which notices of regular and special meetings of City Council, meetings of City boards and commissions, and other public notices shall be posted for purposes of compliance with the Colorado Open Meetings Law, C.R.S. § 24-6-402(2)(c):

Section 3. The meeting notices, and specific agenda information if available, will be posted at the location identified in Section 1 or Section 2 above, as applicable, not less than 24 hours before the commencement of the posted meeting. The City may, in its discretion, post notice in the physical location designated in Section 2 in addition to posting notice on the City's website. However, nothing in this

Resolution requires the City to post notices in the physical location in addition to posting such notices on the website.

Section 4. Notices and other information required to be published in a newspaper of general circulation within the City of Leadville shall be made in The Herald Democrat; except that, where the City determines that the submission schedule, publication deadline, or other circumstance makes publication in such newspaper ineffective or otherwise undesirable, the City may publish official notice in another newspaper of general circulation.

<u>Section 5.</u> City Council directs the Deputy City Clerk to provide the address of the City's website to the Colorado Department of Local Affairs (DOLA) for inclusion in the inventory maintained by DOLA pursuant to C.R.S. § 24-32-116.

**Section 6.** This Resolution shall be effective upon its adoption.

A RESOLUTION FOR A SUPPLEMENTAL BUDGET FOR UNANTICIPATED REVENUES AND APPROPRIATING ADDITIONAL SUMS OF MONEY TO DEFRAY UNANTICIPATED EXPENDITURES IN EXCESS OF AMOUNTS BUDGETED FOR THE GENERAL FUND AND THE FIRE OPERATIONS FUND OF THE CITY OF LEADVILLE, COLORADO.

**WHEREAS**, the annual budget for the City of Leadville, Colorado, for the fiscal year beginning January 1, 2022 and ending December 31, 2022 has been approved by the City Council; and

WHEREAS, the said City Council held a public hearing on said budget and approved said budget and made appropriations in accordance therewith; and

**WHEREAS,** it has become apparent that certain adjustments are necessary to reflect unanticipated expenditures and revenues which have occurred during the 2022 budget year; and

**WHEREAS,** due primarily to creating a street paving fund and the purchase of capital assets in the General Fund; and

**WHEREAS,** due primarily to unanticipated expenditures for wildland fire deployments and the purchase capital assets in the Fire Fund.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado, as follows:

**Section 1**. The City Council hereby approves the following supplemental appropriations from the General Fund for Fiscal Year 2022 for the purposes stated:

City Hall Operating Expenditures	\$1,100,000
Police Operating Expenditures	\$20,000
Street Operating Expenditures	\$650,000
Animal Shelter Operating Expenditures	\$20,000

That the 2022 appropriations for the General Fund expenditures is hereby increased from \$5,754,282 to \$7,544,282

**Section 2**. The City Council hereby approves the following supplemental appropriations from the Fire Department Fund for Fiscal Year 2022 for the purposes stated:

Wildfire Operating Expenditures	\$275,000	
Fire Capital and Training Expenditures	\$120,000	
Wildfire Operating Revenue	\$300,000	
Fire Capital and Training Revenue	\$22,000	

That the 2022 appropriation for the Fire Operations Fund expenditures is hereby increased from \$2,074,583 to \$2,469,583.

That the 2022 appropriation for the Wildfire Operating and Fire Capital and Training revenue is hereby increased from \$379,763 to \$701,763.

<u>Section 3</u>. The supplementary budget is hereby approved and adopted and shall be signed by the Mayor and made a part of the public records of the City of Leadville.

### I. REQUEST OR ISSUE:

Before City Council for consideration is Ordinance No. 1, Series of 2023 ("Ordinance"), which would place a temporary moratorium on the acceptance and processing of applications for new business licenses for the sale, rental, or leasing of off-highway vehicles ("OHVs") within the City.

### II. BACKGROUND INFORMATION:

The City is pursuing the implementation of new regulations for OHVs, and the purpose of the temporary moratorium is to preserve the status quo while the new regulations are developed.

The moratorium would be effective until January 18, 2024. This time period would be approximately ten (10) months from the effective date of the Ordinance. Under the Ordinance, the City has the option of terminating the Ordinance sooner than January 18, 2024, if desired or needed.

Should City Council adopt this Ordinance, no new business license applications for the sale, rental, or leasing of OHVs may be accepted or approved until the Ordinance is repealed or terminates. This moratorium would not affect any existing business licenses. There are currently two existing OHV business licenses issued by the City.

## III. FISCAL IMPACTS:

### V. LEGAL ISSUES:

This Ordinance would adopt a lawful moratorium because it is for a reasonable duration (approximately 10 months) and for a legitimate government purpose (provide the City time to consider and implement new OHV regulations).

When a municipality adopts an ordinance creating a moratorium, such as one that temporarily stops the City from granting new licenses or permits, such action can raise eminent domain concerns under the Takings Clause of the United States Constitution. When determining whether a temporary moratorium is a "taking" that, under principles of justice and fairness, requires compensation, courts consider factors of each particular situation, such as the economic impact of the regulation, the extent to which the regulation has interfered with distinct investment-backed expectations, and the character of the governmental action.

However, moratoriums that are reasonable in duration and made in good faith for a legitimate government purpose (e.g., to complete a decision-making process regarding potential municipal code amendments) do not constitute a taking or require compensation to a property owner.

In Colorado, courts have upheld moratoriums for as long as ten (10) months, including in *Williams v. City of Central* when Central City enacted a moratorium on issuing licenses for new casinos while it studied the impact of allowing more casinos into the community. Depending on the reason for the moratorium, the reasonable time could be longer. In 2002, for example, the U.S. Supreme Court upheld a development moratorium in California that lasted thirty-two (32) months to allow for the completion of environmental assessments and reports on Lake Tahoe.

## VI. STAFF RECOMMENDATION:

Staff recommends adopting Ordinance No. 1, Series of 2023 on first reading and schedule second reading for a date certain.

## CITY OF LEADVILLE, COLORADO ORDINANCE NO. 1 SERIES OF 2023

## AN ORDINANCE ESTABLISHING A TEMPORARY MORATORIUM ON THE ACCEPTANCE, PROCESSING AND APPROVAL OF ANY NEW BUSINESS LICENSES FOR THE SALE, RENTAL, OR LEASING OF OFF-HIGHWAY VEHICLES IN THE CITY OF LEADVILLE

- WHEREAS, the City Council of the City of Leadville ("City Council") possesses the authority pursuant to C.R.S. § 31-15-401 and its general police powers to pass and enforce regulations which may be necessary or expedient for the promotion of the health, safety and welfare of the citizens of Leadville; and
- WHEREAS, the City Council is authorized pursuant to C.R.S. § 31-15-501 to license and regulate any lawful occupation, business place, amusement, or place of amusement and to fix the amount, terms and manner of issuing and revoking licenses issued therefor; and
- **WHEREAS,** 5.04.010 of Title 5 of the Leadville Municipal Code ("Code") requires that "every person, firm, partnership, corporation or other business entity must obtain a business license from the city before operating, conducting or carrying on any for-profit retail trade, profession or business within the city"; and
- WHEREAS, the City Council is further authorized pursuant to C.R.S. § 33-14.5-110 to regulate the operation of off-highway vehicles ("OHV") on public lands, water and property under its jurisdiction and on streets and highways within its boundaries by appropriate ordinance if such regulations are not inconsistent with state law; and
- WHEREAS, the Comprehensive Plan recognizes the importance of tourism's contribution to the economy by bringing outside money into Leadville and Lake County and by showcasing Leadville and Lake County to other areas; and
- **WHEREAS**, the Comprehensive Plan also supports efforts to connect the City to neighborhoods and destinations in the unincorporated County while balancing safety and emergency services; and
- WHEREAS, Lake County previously adopted ordinance No. 12-02 approving all County Roads designated for multi-purpose use which includes the regulation of OHVs; and
- **WHEREAS,** Lake County is undertaking a comprehensive review of both current and future uses of OHVs; and
- WHEREAS, the City Council desires to develop fair, clear OHV licensing regulations, consistent with Lake County and in accordance with the goals and strategies set forth in the City's Comprehensive Plan; and

WHEREAS, the City recognizes the importance of establishing the appropriate balance between the varying goals in the City's Comprehensive Plan of attracting new businesses, supporting existing businesses, encouraging tourism, and promoting businesses that serve both local residents and visitors and that augment the inventory of businesses within the City serving the day-to-day needs of residents; and

WHEREAS, pursuant to the authority stated herein, the City Council finds that a temporary moratorium until and including Thursday, January 18, 2024 on the issuance of new business licenses for the sale, rental, or leasing of OHVs, as defined in this Ordinance, is reasonable and necessary to allow the City time to properly investigate and develop, and if appropriate, adopt and implement new or revised regulations concerning OHVs necessary to best preserve the health, peace and safety of the City.

# NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF CITY OF LEADVILLE, COLORADO, AS FOLLOWS:

**Section 1. Recitals.** The foregoing recitals are hereby adopted as findings of the City Council and are incorporated herein by this reference.

Section 2. Moratorium. No applications for new business licenses for the sale, rental, or leasing of OHVs under Title 5 of the Code shall be accepted, reviewed, considered or approved until such time as this Ordinance is terminated or repealed, unless otherwise expressly provided by this Ordinance. The provisions of this Ordinance are temporary in nature and intended to be replaced or repealed by a subsequent legislative enactment. The temporary moratorium established by this Ordinance shall automatically terminate and this Ordinance shall automatically be repealed as of 11:59 P.M. on Thursday, January 18, 2024, unless terminated earlier by City Council or extended in its duration by the enactment of another ordinance. Nothing contained in this Ordinance shall be construed to limit or preclude the City Council from termination, repeal, amendment, or modification of this Ordinance prior to the date and time of expiration and repeal.

**Section 3. Definition.** "Off-highway vehicle" means any self-propelled vehicle which is designed to travel on wheels or tracks in contact with the ground, which is designed primarily for use off of the public highways, and which is generally and commonly used to transport persons for recreational purposes. "Off-highway vehicle" does not include the following:

- 1. Vehicles designed and used primarily for travel on, over, or in the water;
- 2. Snowmobiles;
- 3. Military vehicles;
- 4. Golf carts;
- 5. Vehicles designed and used to carry disabled persons;
- 6. Vehicles designed and used specifically for agricultural, logging, or mining purposes; or
- 7. Vehicles registered pursuant to Article 3 of Title 42, C.R.S.

Section 4. Preservation of Status Quo and Violation. Any person or entity that has received a business license from the City prior to the effective date of this Ordinance may continue to rely on such licenses throughout the duration of this Ordinance. Any person who violates this Ordinance may be subject to the general penalty provisions of the Leadville Municipal Code and enforcement action in Leadville Municipal Court.

**Section 5. Remaining provisions.** Except as specified in this Ordinance, all other provisions of the Leadville Municipal Code shall continue in full force and effect. This Ordinance makes no amendments to the Leadville Municipal Code and temporarily suspends the provisions specified herein only.

**Section 6. Severability.** Should any one or more sections or provisions of this Ordinance be judicially determined invalid or unenforceable, such judgment shall not affect, impair or invalidate the remaining provisions of this Ordinance, the intention being that the various sections and provisions are severable.

**Section 7. Repeal.** Any and all ordinances or codes or parts thereof in conflict or inconsistent herewith are, to the extent of such conflict or inconsistency, hereby repealed; provided, however, that the repeal of any such ordinance or code or part thereof shall not revive any other section or part of any ordinance or code provision heretofore repealed or superseded and this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance or code hereby repealed prior to the taking effect of this ordinance.

**Section 8. Safety Clause.** The City Council hereby finds, determines, and declares that this Ordinance is promulgated under the general police power of the City of Leadville, that it is promulgated for the health, safety, and welfare of the public, and that this Ordinance is necessary for the preservation of health and safety and for the protection of public convenience and welfare. The City Council further determines that the Ordinance bears a rational relation to the proper legislative object sought to be attained.

**Section 9. Effective Date.** This Ordinance shall become effective thirty (30) days after publication following final passage.
