I. REQUEST OR ISSUE:

Before City Council is Resolution No. 1, Series of 2024, (the "Resolution"), which declares a vacancy in, and appoints a candidate to fill, the City Council seat for Ward 2b.

II. BACKGROUND INFORMATION:

The seat representing Ward 2b (the "second ward") on the City Council was up for re-election in November 2023. There were no candidates in that election for Ward 2b. In accordance with §1.16.030 of the Leadville Municipal Code and Colorado Revised Statutes §§ 31-4-106 and 31-4-108(2)(b), the City Council must either appoint a person to fill the vacancy within sixty (60) days of the vacancy or schedule a special election.

Making an appointment to fill the vacancy saves the time and expense of conducting a special election. The city advertised the vacancy to seek a qualified candidate to fill the vacancy in Ward 2b. The city received letters of interest from two candidates – Shannon Grant and Timothy Best.

The person appointed will serve until the next regular election in November 2025.

III. FISCAL IMPACTS:

IV. LEGAL ISSUES:

When a vacancy in a city council seat occurs, Council must adopt a resolution declaring the vacancy. The adoption of that resolution starts a 60-day clock. The City has 60 days (per C.R.S. 31-4-106 and 31-4-108(2)(b)) from the adoption of the resolution, or the date of vacancy declared in the resolution if different from the resolution adoption date, to either appoint a person to fill the vacancy or call a special election to fill the vacancy. If the City does not appoint someone to fill the vacancy in 60 days, then the City will need to call a special election. Here, City Council is presented with Resolution No. 1, Series of 2024 declaring a vacancy and determining to appoint a person to Council to fill the vacancy.

Per C.R.S. 31-4-106, any person appointed (or elected) to City Council must meet certain statutory requirements in order to hold that office. The person must be a resident of the ward to which they are elected or appointed for at least twelve (12) consecutive months prior to their election or appointment, and they must be a registered elector in their ward.

V. **STAFF RECOMMENDATION:**

Staff recommends that City Council approve Resolution No. 1, Series of 2024 and appoint one of the two candidates to fill the Council vacancy.

WHEREAS, § 2.04.010 of the Leadville Municipal Code (the "Code") states that the City Council shall consist of the mayor and six city council members elected from the three wards of the city;

WHEREAS, the seat representing Ward 2b (the "second ward") on the City Council was up for re-election in November 2023;

WHEREAS, there were no candidates in that election for Ward 2b;

WHEREAS, in accordance with § 1.16.030 of the Code and Colorado Revised Statutes ("C.R.S.") §§ 31-4-106 and 31-4-108(2)(b), the City Council must either appoint a person to fill the vacancy within sixty (60) days of the vacancy or schedule a special election;

WHEREAS, the City Council desires to appoint a person to fill the vacancy in order to save the time and expense of conducting a special election;

WHEREAS, the city has advertised the vacancy to seek a qualified candidate to fill the vacancy in Ward 2b;

WHEREAS, City Council desires to make an appointment from the pool of qualified candidates.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado as follows:

Section 1. The City Council hereby: (1) declares a vacancy in the office of City Council Member for Ward 2b as of January 8, 2024; and (2) determines to fill the vacant Ward 2b seat by appointment.

Section 2. The City Council appoints ______ to serve on the City Council whose term shall commence on taking the oath of office and continue until the term of office of a successor elected at the next regular election on November 7, 2025 has commenced as provided in C.R.S. §§ 31-4-106 and 31-4-108(2)(b).

To the members of the Leadville City Council:

I am writing to express my interest in serving as council member representing ward 2, as well as to describe my experience and skills relevant to this position. I believe my background of diverse professional exposures, as well as my work here in Leadville, makes me a great candidate to serve on the council.

I moved to Leadville in the summer of 2016 after a radical career change. In my previous career path, I was an academic at elite arts institutions for a total of twelve years, teaching courses in ethnomusicology and music theory and doing research in semiotics and hermeneutics. Before that, I developed extensive experience in the service sector, managing several small businesses including my own start-up coffee shop. What brought me to Leadville? Like many folks that I've gotten to know here, it was simply a feeling that this was "my place," - a sense of belonging here that was borne partly of my love of mountains and adventuring, but also the uniqueness that Leadville embodies compared to every other mountain that I've experienced. Namely, that this is a real place with real working people, with real character, joys, and struggles.

Since moving here, I have been working with the children of Leadville and Lake County primarily in out-of- school time. Most recently, as Out-of-School-Time Programs Director for Get Outdoors Leadville! and Camp Director for Rockies Rock Adventure Camp, my primary focus has been to cultivate a passion for the outdoors as an arena for growth, discovery, collaboration, achievement, and stewardship, as well as to address the inequities of the Latino community here in experiencing our wonderful natural spaces. As Site Director of Project Dream after-school programs at West Park Elementary School, my focus was enrichment – to enable kids to foster a wide variety of interests, and possibly discover untapped gifts and talents while also growing socially and emotionally. Working in these two interdependent domains has allowed me to build relationships with a large number of Lake County youth and families, as well as local partners in the non-profit sector. I feel invested in the present and future well-being of Lake County families and want to help ensure that Leadville grows as a place that offers plentiful opportunities for them (recreational, intellectual, and economic).

I excel at problem-solving and logistics and thrive in collaborative environments. I have an entrepreneurial spirit and am skilled at program implementation and management. My wish is to put these skills to practice in the service of the Leadville community by representing Ward 2.

Since leaving my career as a college professor, I am sometimes asked what the common ground is between my previous life as an academic and the new one I've found here in Leadville. I've come to realize that the answer lies in a common goal — to improve and advance the culture of our society. My work in the Leadville community is now the most important work I've ever done toward this goal, and I look forward to discussing with you how I might continue this work as a member of the council.

I. <u>REQUEST OR ISSUE</u>:

Staff requests that council adopt Resolution 5, Series of 2024 a Resolution Designating the Official Public Notice Location and the Official Newspaper of General Circulation for the City of Leadville, Colorado.

II. <u>BACKGROUND INFORMATION</u>:

Colorado Revised Statutes §24-6-402(2)(c) requires that the public place or places for posting notice of public meetings be designated annually at the local public body's first regular meeting of each calendar year. The city has traditionally posted notice of its public meetings (city council and commissions) on the front door of city hall, on the city's website and in the *Leadville Herald*.

III. FISCAL IMPACTS:

There is no fiscal impact of this motion.

IV. **LEGAL ISSUES**:

This Resolution is necessary to comply with Colorado Revised Statutes §24-6-402(2)(c).

VI. STAFF RECOMMENDATION:

Staff recommends that the council adopt Resolution 5, Series of 2024 a Resolution Designating the Official Public Notice Location and the Official Newspaper of General Circulation for the City of Leadville, Colorado.

CITY OF LEADVILLE, COLORADO RESOLUTION NO. 5 SERIES OF 2024

A RESOLUTION OF THE CITY COUNCIL OF LEADVILLE DESIGNATING THE OFFICIAL PUBLIC NOTICE LOCATION AND THE OFFICIAL NEWSPAPER OF GENERAL CIRCULATION FOR THE CITY OF LEADVILLE, COLORADO

- **WHEREAS**, C.R.S. § 24-6-402(2)(c) requires the annual designation of the City's official public posting location for notices of regular and special meetings;
- WHEREAS, C.R.S. § 24-6-402(2)(c) also states that the Colorado General Assembly intends for local governments to transition from posting notices in physical locations to posting notices online to the greatest extent practicable so long as the online posting location requirements of state law are met;
- **WHEREAS**, City Council believes that posting notices on the City's website is a more effective and accessible means of dissemination and provides more flexibility than the physical posting location;
- **WHEREAS**, the City Council wishes to continue posting notices in a physical location to the extent practicable or when emergency circumstances exist such that posting on the website is not possible;
- **WHEREAS**, the City of Leadville is also required by state law to publish certain notices in a newspaper of general circulation; and
- **WHEREAS**, City Council desires to designate the City's website as the official posting location, while continuing to post at its physical posting location when practicable or necessary, as well as designate its newspaper of general circulation for calendar year 2024.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado, as follows:

- Section 1. The City of Leadville website, https://cityofleadville.colorado.gov. is hereby designated as the place at which notices of regular and special meetings of City Council, meetings of City boards and commissions, and other public notices shall be posted for purposes of compliance with the Colorado Open Meetings Law, C.R.S. § 24-6-402(2)(c).
- Section 2. In exigent or emergency circumstances that prevent the City from posting a meeting notice or other public notice on the City's website, the following location is hereby designated as the place at which notices of regular and special meetings of City Council, meetings of City boards and commissions, and other public notices shall be posted for purposes of compliance with the Colorado Open Meetings Law, C.R.S. § 24-6-402(2)(c):

City Hall (on the front doors) 800 Harrison Avenue Leadville, Colorado, 80461 <u>Section 3</u>. The meeting notices, and specific agenda information if available, will be posted at the location identified in Section 1 or Section 2 above, as applicable, not less than 24 hours before the commencement of the posted meeting. The City may, in its discretion, post notice in the physical location designated in Section 2 in addition to posting notice on the City's website. However, nothing in this Resolution requires the City to post notices in the physical location in addition to posting such notices on the website.

Section 4. Notices and other information required to be published in a newspaper of general circulation within the City of Leadville shall be made in The Herald Democrat; except that, where the City determines that the submission schedule, publication deadline, or other circumstance makes publication in such newspaper ineffective or otherwise undesirable, the City may publish official notice in another newspaper of general circulation.

Section 5. The City Clerk is directed to provide the address of the City's website to the Colorado Department of Local Affairs (DOLA) for inclusion in the inventory maintained by DOLA pursuant to C.R.S. § 24-32-116.

Section 6. This Resolution shall be effective upon its adoption.
