**Police -** Bertolas, No report, due to the recent resignation of admin Hack. Admin position has been posted. Several cadets have been interviewed but they still need to graduate for the academy. Current staff has stepped up and has been very helpful while the department has been short staffed.

**Animal Shelter** – Labbe, spoke about the severe dog problems at Lake Fork and how that issue is being addressed. Bertolas, Reyes, Ruma, Labbe and Dallas all met to come up with a plan of action and next steps. The City is distributing an educational flyer explaining licensing and laws. Labbe and Bertolas, will be meeting with the Woman's Empowerment Group to help educate them on the issue and current laws.

**Fire** - Dailey, spoke about the structure fire that took place on Friday. The Fire Department was successfully in saving all surrounding structures and commended the fire fighters with a job well done. The Decker Fire on is currently under control and Leadville fire fighters that are down there are expected home soon. There was a Fire Dept. meeting on 10/15 where they discussed the strategic plan, core values and improvements to programs. He mentioned, 30 short term fire checks.

**Street** – Labbe, reported that the Street Dept. is up on patching

**Admin** – Dallas, explained that the city is currently inundated with short term rental applications. The annual Mainstreet check in took place. She also, shared with council the various issues she has been working on: Budget issues, ordinances, conditional use permits, site review process -conflicting codes – discussions about code changes, accessory dwellings, variance issues, density and completion of site plan for Tritz Park and sign program.

**Liquor** - Nothing to report

Financial - Labbe, thinks we are looking good on Budget.

**Bills** – Labbe, clarified the bills for paving projects: \$23,000 - 9<sup>th</sup> & Pine, \$13,000 - visitors center parking lot.
