a. Colorado Gives Day Proclamation

i. Mayor Labbe made an official proclamation that the City of Leadville will participate in Colorado Gives Day on December 5th.

b. Railyard Phase 1 Subdivision Improvement Agreement Enforcement/Escrow Update

- i. Planning Director LaChance gave updates regarding recent deadlines, new agreements, upcoming deadlines, newspaper coverage, and accounting of multiple escrow accounts.

c. Police Department Budget Discussion

- i. City Administrator Simonson gave a presentation showing 4 options of what we can do to help the immediate situation regarding the Leadville Police Department.
- ii. Option 1 Maintain the Leadville Police Department and Re-Staff
 - 1. Hire a new police chief
 - 2. Hire additional law enforcement officers over time to ensure 10 hour shifts
 - 3. Maintain the current administration (1 Administrative supervisor, 1 administrative assistant and 2 community service
- iii. Option 2 Dissolve the Leadville Police Department and Merge with the County Sheriff
 - 1. Transfer all personnel? Salary? Positions?
 - 2. Transfer all vehicles?
 - 3. Transfer all equipment?
 - 4. Order new uniforms, badges, other new equipment
 - 5. Locate space for staff
 - 6. Train all new employees
- iv. Option 3 Contract for Law Enforcement with the County Sheriff
 - 1. Contract with the Sheriff for law enforcement coverage
 - 2. Keep municipal code functions in the City (Correction municipal code violations would still be written into the Municipal Court)
 - 3. Keep administrative functions in the City
- v. Option 4 Combine the County Sheriff with the Leadville Police Department

- 1. Calls for service, patrol and law enforcement functions in the City
- 2. Sheriff to provide statutory duties of oversight of prisoners and jail executions of warrants
- 3. Keep municipal code functions in the City (Correction municipal code violations would still be written into the Municipal Court)
- vi. Most City Council members voted for options 3 or 4, Councilmember Grant strongly agrees with option 1.

 - i. John Lichtenegger did not do what he promised. He received \$51,000, there are no ADA ramps, no plow service, no actual parks (just open fields). The developer has snubbed his nose at all of us and it's time to hold him accountable.

 - i. They were told there wouldn't be any further extensions and that 10/31/2023 was a hard deadline, but now the developer is getting another extension.

 - a. Agenda Revisions: None
- 5. Housekeeping Matters:
 - a. There are street lights that are out. Needs wiring fixed. The Street Department is aware and is working on it.
 - b. Election Results
 - i. MPT Greene has officially been elected Leadville's first female Mayor
 - ii. Ward 1 Joey Edwards
 - iii. Ward 3 Cisco Tharp
 - c. January 2nd will be the swearing in ceremony for new members of City Council, Mayor, and appointments for Ward 2, City Clerk, and City Treasurer
 - d. Senator Bennet gave Leadville a U.S. flag that was flown at the U.S. capitol in Washington D.C.

6. Public comments for items not on the agenda:

- a. Steve Prestash
 - i. The homelessness situation needs to be addressed and the City needs to project for that in the future.
 - ii. Worst thing to happen to him in 43 years is the decision to dissolve the police department, which will lead to danger of diminishing residents voice and giving power to the developers. This will strangle the police department as there is no due diligence for upkeep.
 - iii. This administration has allowed someone to buy up a lot of property over the last 8 years.
- b. Nancy Bailey
 - i. Thanked Mayor and Council
 - ii. Invited everyone to participate in "Shop Small Saturday" on 11/25 from 12-4 p.m. There will be a "melly" auction and other goodies.
 - iii. Excited about next week's presentation.

7. Department Reports: Included in the Packet - No Verbal Presentations

- a. City Bills
 - i. MPT Greene **moved** to pay the bills, CM Luna-Leal **seconded** the motion. All present were in favor.

8. Action Items:

a. Resolution No. 25, Series of 2023: A Resolution Authorizing a Financial Contribution to Certain Charities for Colorado Gives Day

CM Luna-Leal moved to approved Resolution No. 25, Series of 2023: A Resolution Authorizing a Financial Contribution to Certain Charities for Colorado Gives Day, CM Thomas seconded. All present were in favor.

9. Presentations and Discussions:

- a. City Administrator's Report:
 - i. Will ask for letters of interest for Ward 2, City Clerk, and City Treasurer. Theses seats will be filled by appointment. City Administrator checked with our attorneys to make sure there was no conflict of interest if deputies are clerks/treasurers. If the Deputy City Clerk and the Financial Director assumed these rolls, it would eliminate confusion.
 - ii. January 2nd will be the swearing in of new City Council members, Mayor, and appointment of Ward 2, City Clerk, and City Treasurer. January 8th will be the official day they take office.
 - iii. The Tabor received a DOLA grant for a rehabilitation project to finish the last part of the exterior. There was an article in the Summit Dailey announcing this.

- iv. City Administrator is making an offer tomorrow for the roll of administrative assistant who would support the City Administrator and the Finance Director.
- v. Property tax revenue will there be a credit? reduce mills? Spoke with attorney and they said a credit back would be a better way to go - it's allowed to be temporary.
- vi. Colorado Municipal League announced that the Colorado General Assembly convened to assess property taxes.

b. Leadville Lake County Emergency Operations Plan Presentation:

- i. In October, Emergency Operations Plan Director Claire Skeen came to City Hall to discuss changes to the plan and ask for approval. She was able to incorporate those changes in this city council meeting packet.
- ii. Thanked Chief Dailey for his contributions and edits.
- iii. Feedback outstanding regarding funding mechanisms this doesn't affect "bones" of the plan.
- iv. There is a formal approval process every 3 years. This is a "living document" that can be reviewed/changed every year.
- v. There was a change in the types of radios emergency responders use there was a spark that would come out of the old radio when using it in communications that could be dangerous. The new radios are safer to use in dangerous situations and it uses an electrical signal.
- vi. There will be an official resolution for the next City Council meeting to adopt the new Emergency Operations Plan.
- vii. CM Luna-Leal **moved** to adopt the new Emergency Operations Plan, CM Grant **seconded**. All present were in favor.

c. Stage and Rail Trail Financial Request:

- i. Proposed historic route in Lake County:
 - 1. 16 miles of the historic stage and rail route in Lake County is ready for designation pending resolution of private property liability issues along the Pipeline Road.

ii. Next Steps:

- 1. Future oversight may be vested in Lake County Parks, Recreation and Open Space Department.
- 2. Focus shifts from route designation to public education and interpretation.
- 3. Grant application for two-year support pending with Colorado Parks and Wildlife Trails grant program.
- 4. Match funding from Lake County and Chaffee County Commissioners, Buena Vist and Salida.
- 5. Requesting match funding from Leadville City Council: \$1800 cash, \$250 in-kind.

iii. An official resolution will be presented at the next city council meeting to approve funds. Documentation and an invoice is needed.

d. Further Police Department Discussion:

- i. Continuation of previous discussion still alot to figure out
- ii. Can do better at making decisions carefully
- iii. City Administrator provided different scenarios in several cities dealing with the same situation. Analyze and pick out best parts of all of the example contracts.
- iv. Have police department cover certain shifts and the sheriff's department cover others
- v. Had a productive meeting with the police department. Wants to prevent burn-out, they said they're ok right now, morale is good. Asked if they would be ok with an interim situation and they said that would work for them.
- vi. POST is vague about interim situations regarding maintaining records, evidence, oversight of community service officers, etc.
- vii. POST wants to know where Leadville stands before they answer other questions.
- viii. Need an animal control officer ASAP. Animal Shelter staff are civilians, law enforcement is not trained to handle animals.

 - i. Water issues, change in snowfall, Colorado is in a "brown zone"
 - ii. What would happen if we ran out of water
 - iii. Development and progress are 2 different things
 - iv. We depend on our snowfall who will be impacted? Switzerland saves snow and tarps it for future water usage.
 - v. Canterbury Tunnel could be a source of water as needs changed based on climate change
 - vi. Camp Hale Climax water processing facility
 - vii. No rattlesnakes due to harsh weather conditions

- a. Attended a fundraiser for PbSwims with a dinner at ZeroDay
- **b.** Kyle Crawford had an event at his place and made a donation of about \$3000 to PbSwims
- c. People are really rallying for a pool

A RESOLUTION ADOPTING THE EMERGENCY OPERATIONS PLAN FOR THE COUNTY OF LAKE, STATE OF COLORADO

WHEREAS, pursuant to the requirements of C.R.S. §24-33.5-707(8), each County disaster agency shall prepare and keep current a county disaster emergency plan for its area; and

WHEREAS, the purpose of the Presidential Policy Decision Directive is to enhance the ability of the United States to manage domestic incidents by establishing a single, comprehensive national incident management system; and

WHEREAS, Lake County has in place an Emergency Operations Plan ("EOP") which is the county disaster emergency plan for our area; and

WHEREAS, the EOP is a living document and outlines the roles and responsibilities of the different organizations in Lake County in the event of a disaster or emergency; and

WHEREAS, the Lake County EOP needed to be updated in order to be compliant with the new guidelines that the Colorado Division of Homeland Security and Emergency Management ("DHSEM") issued in January of 2023; and

WHEREAS, Claire Skeen, the Director of the Office of Emergency Management") made a presentation about the updated EOP to the City Council at its regularly scheduled meetings on October 3 and November 21, 2023; and

WHEREAS, the City Council expressed support for adoption of this plan.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado, as follows:

The City Council hereby authorizes adoption of the 2023 Lake County Emergency Operations Plan as presented to the City Council on November 21, 2023. The Council further authorizes the City Administrator along with the Director of Emergency Operations to make any non-substantial changes as necessary to the EOP that was presented on November 21, 2023.
