Call to order of regular meeting – 6:02 p.m. Pledge of allegiance Roll call Approval of agenda –

- CM Gowing, moves to approve agenda, CM Greene, seconds, unanimous approval

Agenda of minutes

- a. Minutes from January 21, 2020
 - Mayor Labbe, requested 2 changes: (1) the meeting on 2/6, in the Planner be changed to say, Fire Management Board and (2) at the end of the minutes, before council reports that it states; that staff was instructed to create two resolutions for the 2/4 city council meeting. One for a 2year term for the appointment of the Municipal Court Judge, and one for a 90day interim appointment of the Municipal Court Judge.
 - CM Forgensi, moves to approve Jan 21, 2020 minutes with suggested changes, CM Gowing seconded, unanimous approval

A. Hear from Megan Jackson, discussion about ADU's and STR's

• Background information:

"In 2016 the Leadville Planning Commission and City Council passed Accessory Dwelling Unit language. Part of that deliberate discussion and conversations centered around long-term vs. short-term rental properties and adding a rental unit on a property, included whether the ADU's should be long-term or short-term rental options. The discussion and current code states that ADU's cannot be rented for less than 30 days." ASM Dallas, staff report 2/4/2020 Now that the city is requiring all Short-Term Rentals apply for a license, we are now seeing that this issue needs to be addressed. Due to the law, staff has not processed any ADU STR applications and are asking council how to proceed. Meghan Jackson, expressed her frustration with staff and was asked to share her thoughts with council.

- Mrs. Jackson, explained to council that she and her husband purchased their home in 2017, with the intent of short-term renting the carriage house on the back of their property for additional income. Mrs. Jackson had two requests for council, (1) that there be a six-month moratorium put on her property so that they can fulfill current reservations and (2) that during that six-month period that council grand father in their property for short-term rental use.
- Council recommended that this discussion go back to the Planning Commission for review and that during that time staff will come up with a way for owners of ADU's



that are short-term renting those properties to self-report, in good faith, so that they are not fined during this review process for noncompliance.

B. CUP for 700 E 11th Street Telecommunications Tower

- CM Gowing, informed council of ex parte communication that she had with Sheriff Reyes, at the end of the Open House, inquiring if there would be more information available. CM Gowing, confirmed that she would still be able to make an impartial judgment on the CUP
- CM Forgensi, moves to approve the Conditional Use Permit and Height Exemption for the Lake County Emergency Services telecommunication tower and accessory equipment installation subject to the following conditions:
- 1. A legal description of the property prepared by a licensed Colorado land surveyor as required by Ordinance 17.72.070 (inclusive of the land area contained in the scope of this application. (Lots 17, 18, 19, 20, 21, 22, and 23 Block 35, North Leadville Addition to the City of Leadville, County of Lake, State of Colorado. (7 lots @ 25' x 110'= 19,250 sq. ft or .44 acres more or less).
- 2. A title commitment and title search of any easements or encumbrances of record.
- 3. Formal lease agreement with the City of Leadville to grant authority for the use of city owned property including the construction of the tower, subject to the CUP conditions. There is currently no record of the uses and improvements on this property as a public facility containing VHF and HAM radio facilities.
- 4. Improvement costs, whether to be paid by Lake County or monies given by the State, shall be determined to assure compliance with the commitments noted in the CUP.
- 5. Provide the necessary signature blocks for Planning Commission and City Council approval.

Additional Planning Commission Recommended Conditions:

- 6. The tower height shall not exceed 75 feet and whip antennas shall not exceed an additional 10 feet for a total height of 85 feet.
- 7. Site layout and landscaping shall reflect the site plan illustrations provided in the application.
- 8. The tower should remain unpainted and communication disk to be painted at the discretion of staff.
- 9. Electronic shed(s) will approximate the color of surrounding EOC buildings.
- 10. Re-review/consideration of the CUP for any future co-location facilities on the site or lease agreement for co-location will be required.
- 11. Should the tower become obsolete, the tower will be removed by the County, at the County's expense.
 - MPT Lauchner seconds, unanimous approval
