Tabor Opera House Preservation Foundation Grant Writing Request

Stephanie Spong explained the rehabilitation process and the recent grant awarded. Mayor Labbe questioned the choice of grant writer and Stephanie explained the recommendation of the writer and her experience fighting for this

Mayor Labbe suggested this come from the contingency line item, ASM Dallas clarified there is 26k in that account. CM Roti moved, CM Beck seconded.

Ordinance 1, Series 2018 Liquor License Types Amendment first reading

Clerk Maher explained that the City does not currently have this type of license available and is necessary for any type of recreation facilities. CM Beck moved, CM Gowing seconded.

CM Beck moved to close hearing, CM Roti seconded. ASM Dallas pointed out page 2 in Staff report and wanted to point out that the Greene's were wanting to be thorough and address this.
