## Tuesday, November 30th, 2021 – 6:00 P.M. SPECIAL COUNCIL MEETING MINUTES 800 HARRISON AVE, LEADVILLE, CO.

Call to order of special budget work session meeting at 6:04 p.m. in Council Chambers and via Zoom.

**Roll call:** CM Lauritzen, CM Hill, Mayor Labbe, CM Gowing, CM Forgensi, and CM Tharp were present. MPT Greene joined the meeting at 7:00 p.m. CM Forgensi left the meeting at 7:30 p.m.

**Approval of the agenda**: CM Hill moved to approve the agenda. CM Gowing seconded. Passed by all present.

**Housekeeping matters:** Mayor Labbe and Christiana McCormick have been working on the IGA for the December 7<sup>th</sup> agenda. Mayor Labbe has a meeting with Commission Marcella tomorrow to discuss the allocation of the ARP funding

Mayor Labbe gave an update on PTO Payout request that the Fire Department proposed. This policy change would only include 3 people and at this time it was recommended to not pursue that policy change.
