Call to Order of regular meeting Pledge of Allegiance. Roll Call.

Housekeeping Matters

ASM Dallas mentioned that the tv's should be up and running by the next meeting Public Comments about items not on the agenda.

Rod Weston: Thanked CM Hagen for meeting with him. Requested that the auditors look into specific expenditures related to police vehicle purchase. He also indicated he was concerned about the Mayor attempting to modify city code in regards to the table of uses, for breweries brew pubs and distilleries in regards to Periodic Brewing.

Department reports

Police: Chief Bertolas went over the written report. She is looking to hire School Resource officer at LCSD. There are two candidates who have oral boards with committee – neither are SRO certified and it will be a two week program to get them certified for next year.

Animal Shelter: 2 dogs were placed outside of the county. She went over the report and explained what a great job Deb is doing.

Fire: It has been a very busy year with car accidents on the highway that have douibled, avalanches and structure fires. They are fully staffed and testing for the department. Station 2 is coming along as well, per Chief Dailey.

Street: Tyler explained that they had Ski Joring and a lot of snow at the same timwe and that they are doing the best that they can. There are slush and drainage issues. The Mayor questioned the cost of contractors and they suggested around \$26,000. They are trying to open and widen roads right now and folks parking in roads is making that difficult. They are havign to haul snow out of alleys due to roofs piling off into the roads and alleys.

Admin: There have been a lot of land use applications prepping for building season. She explained the Mian Street projects like Zaitz Park and grant applications. She also mentioned the Tabop Opera House DOLA presentation for \$850,000. ASM Dallas also explained that she has been busy working on the Mtn View Extension project as well.

Planning & Zoning Appointment of Augustina Remedios - Appointed.

Brief Presentation by Cameron Millard with C4
