**Call to order of regular meeting -** 6:02 p.m.

Pledge of allegiance

**Roll call -** CM Forgensi arrived at 6:33 p.m., all in attendance

**Approval of agenda –** CM Greene moved to approve, CM Gowing seconded, unanimous approval by council

**TUP LCHS Request for 5/22/2020 Senior Motor Parade –** CM Greene moved to disapprove a Temporary Use Permit for the LCHS Senior Graduation Motor parade on Friday, May 22<sup>nd</sup> starting at 5:30 p.m. for driving down Harrison Avenue to 3<sup>rd</sup> Street parking lot with a police and fire escort at 6:00 p.m. CM Lauritzen seconded, four in favor, two against and one abstention. LCHS, was invited to apply for TUP with a different idea on the May 19, 2020 city council meeting.

#### Resolution 24, Series 2020, Business Support Program (extension & amendment) -

MPT Lauchner moved to approved a resolution extending and amending the immediate business support program, directing the continued implementation of the program response to the Coronavirus Pandemic, and updating the criteria under which grant applicants may qualify, CM Forgensi seconded, unanimous approval by council

## Discussion with Lake County Commissioners, Dr. Lisa Zwerdlinger and city council -

Dr. Lisa – explained Colorado and Lake County COVID-19 data and encouraged residents to get tested. Testing is free for anyone with a social security number and she recommends that if you are negative that you be retested every six to eight weeks.

Colleen Nielsen, LCPH – explained the criteria that must be met to move into the Stabilization Phase of re-opening. "We won't be able to go back to the way things were and should prepare to move into a new normal."

Commissioner Mudge – currently Lake County cannot currently apply for a variance from the state because we currently do not meet the requirements. BOCC made a motion and voted to cancel all currently permitted events for the summer of 2020 on 5/12/2020

Janeen McGee, Human Services - Spoke about the multiple recovery committees that are being organized to help guide and assist in recovery process and requested any interested parties that would like to help on a committee reach out to her for information.
