Tuesday, June 1st, 2021 – 6:00 P.M. REGULAR COUNCIL MEETING MINUTES 800 HARRISON AVE, LEADVILLE, CO.

Call to order of regular meeting: 6:04 p.m. hybrid meeting model over Zoom and in person in Council Chambers.

Roll call: Council members Gowing, Forgensi, Greene, MPT Lauchner, Lauritzen, and Mayor Labbe were in attendance. CM Hill was absent.

Approval of agenda with additional items added: Add a conversation about the audio for City Hall's hybrid meetings after item J before the executive session. Add a discussion about moving forward with meetings at City Hall in person before executive session. MPT Lauchner moved to approve the agenda with the additions. CM Greene seconded. Passed unanimously.

There were no housekeeping matters.

There were no public comments.

2021 General Election Calendar: The Deputy City Clerk answered questions about election date deadlines. Candidate nomination packets will be available on August 3, 2021.

Department Reports were moved to the Special Meeting on 6/22/21. Reports were available for review Council Packets.

Health & Happiness Report: A presentation by Katie Baldassar from LBAG. Colleen Nielsen from LCHD was also available for comment. Leadville's unemployment for last month was 6.1% and the month before was 5.4% according to Marla Akridge from LCEDC. MPT Lauchner motioned to accept the Lake County Health and Happiness Project Report. CM Greene seconded. Passed unanimously. (6:14 p.m. – 6:32 p.m.)

Irish Network Colorado-Leadville's Irish Miner's Memorial presentation: Introductions by Tess Julian who is the VP of the Irish Network Colorado, Alan Groarke who is the President of the Irish Network Colorado and provided an introduction with background information, Marc De La Torre who is a board member of the Irish Network Colorado and presented the slideshow. Luke Finken who is also on the board of directors for the Irish Network Colorado and Kathleen Fitzsimmons was also in attendance. (6:33 p.m. – 6:49 p.m.)

Earls Marijuana Retail Store Annual 2021-2022 Renewal: Matt Boeve made a presentation. CM Gowing motioned to approve the annual renewal on 6/01/2021 for the retail marijuana store license for Jem Dutch Acres DBA Earls at 115 Harrison Ave and approval of permanent



modification of premises of the entire retail space to be 21+. MPT Lauchner seconded. Passed unanimously. (6:50 p.m. – 6:52 p.m.)

Temporary Use Permit – TransRockies Run: A representative presented for Kevin McDonald. MPT Lauchner motioned to approve Temporary Use Permit for the 14th Annual TransRockies Run on Wednesday August 4th, 2021. Said approval being valid for 3 years, or through 2023. CM Forgensi seconded. Passed unanimously. (6:52 p.m. – 6:57 p.m.)

MPT Lauchner was presented with a copy of a plaque for her service on City Council.

CM Gowing nominated Dana Greene to be the new Mayor Pro Temp. CM Lauritzen seconded. CM Greene accepted the nomination to be Mayor Pro Temp. (8:00 p.m. – 8:07 p.m.)

Audio for City Hall: Council unanimously agreed to accept the contract for the audio options for a hybrid meeting and take the expense out of the building maintenance budget.

Council Break: 8:17 p.m. - 8:25 p.m.

Discussion about moving forward with meetings at City Hall in person: Council unanimously agreed that hand sanitizer, masks, and signage will be placed in the lobby for the public attending City Council meetings. In addition, 6 ft. measurement markings will be placed in front of the Council Chambers bench

No one who participated in executive session found any violations for the Open Meetings Law. MPT Lauchner motioned to reconvene the June 1st regular Council meeting. CM Gowing seconded. Passed unanimously.

Council discussed housing options for City employees and ways to find an interim police chief.
