 - Mayor -Police expenditures -\$6,000 Lexpol not paid. Storage container? MPT Beck moves to pay bills, CM Lauchner seconds.

 requirements, just a checklist. He has invested in land and wants to
 know if things are going to chane greatly which may impact him. T.J.
 responds –we are not adding a tedious process. Req would be
 included in building permit. Mayor CM Laughner MPT Beck seconds to

Mayor asked T.J. to explain why this is being proposed. His response included parking etc... being considered w/design standards. Site Plan Review. Mayor – Parking Standards need to be addressed. (within parking subcommittee recommendations). Mayor Labbe moves to approve. Hagen seconds. All were in favor.

 - Mr. Weston stated that this would not be community wide. Specific to Railyard. Tallest buildings would be down on Hwy 24. Original request vs current request. Max bldg. type, max height allowed and exemptions. CM Green asked specific questions re: amendments. Do they need to add P&Z conditions? T.J.: yes. MPT Beck moves to approve CM Green seconds

 - No gun fights were done on Sunday in honor of this weekends tragedies. Does City Council feel strongly enough to write a letter to the county commissioners in protest? County holds permit for Gun Show.
 - Mayor will check w/Mrs. Maher to see if business licenses are obtained for Boom Days vendors.
 - Mayor: Banning automatic weapons in the county would be a goal.
 - CM Lauchner: Restrictions on future agenda? Ask Bethany.
 - Q:MPT Beck With Mike McHaurge leaving, is the budget now gone? Answer: this is unclear.
 - Cailee Hamm new Director of Emergency Management (?)
 - MPT Beck has requested to have City Council meetings in a separate, safer space. Also has requested to have an armed officer present at each meeting.
