A RESOLUTION APPOINTING AN INTERIM MUNICIPAL JUDGE

WHEREAS, the City is authorized by C.R.S. § 13-10-105 and Sections 2.12.010 and 2.40.040 of the Leadville Municipal Code to appoint a Presiding Municipal Judge for the Leadville Municipal Court; and

WHEREAS, the Municipal Code at Section 2.40.040 sets the term of the Municipal Judge at two (2) years and requires that the Municipal Judge, at all times during the term of office, be currently licensed to practice law in the State of Colorado; and

WHEREAS, Leadville's Presiding Municipal Judge resigned on February 12, 2020, leaving a vacancy in the position of Presiding Municipal Judge for the Leadville Municipal Court; and

WHEREAS, the City desires to fill the vacancy for its Presiding Municipal Judge following a formal request for proposals ("RFP") process; and

WHEREAS, to ensure the continued operations of the Leadville Municipal Court pending the outcome of the RFP process, the City Council desires to appoint an Interim Municipal Judge, as permitted by C.R.S. § 13-10-105, until City Council is able to appoint a Presiding Municipal Judge; and

WHEREAS, C.R.S. § 13-10-106 allows for county court judges to be appointed as municipal judges; and

WHEREAS, Jonathan Shamis is a licensed attorney in the State of Colorado, serves as a judge in Lake County Court, and is qualified to serve as Leadville's Interim Municipal Judge; and

WHEREAS, the City Council desires to appoint Judge Shamis as the City's Interim Municipal Judge, which appointment shall commence on March 3, 2020 and shall expire upon the appointment of a Presiding Municipal Judge.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CENTRAL, COLORADO, THAT:

Section 1. Interim Appointment. The City Council hereby appoints Jonathan Shamis as the Interim Municipal Judge for the Leadville Municipal Court effective March 3, 2020.

Section 2. Termination of Interim Appointment. This interim appointment shall expire upon the appointment of a Presiding Municipal Judge by City Council.

Section 3. Effective Date. This Resolution shall take effect upon its approval by the City Council.
