**A RESOLUTION APPROVING THE LAKE COUNTY & CITY OF LEADVILLE
CORONAVIRUS (COVID-19) RESPONSE PLAN**

WHEREAS, on March 10, 2020, the Governor of the State of Colorado recognized the Novel Coronavirus Disease (“COVID-19”) pandemic and declared a state of emergency; and

WHEREAS, on March 16, 2020, the Lake County Board of County Commissioners issued a local disaster declaration due to the imminent threat from widespread or severe damage, injury or loss from the COVID-19 pandemic; and

WHEREAS, the President of the United States declared a national emergency concerning the COVID-19 outbreak on March 13, 2020 to implement additional measures to contain and combat the virus in the United States; and

WHEREAS, the World Health Organization has declared COVID-19 to be a worldwide pandemic; and

WHEREAS, the City of Leadville (City”) has the authority to provide for the health, safety and welfare of the public pursuant to C.R.S. § 31-15-401 and its general police powers; and

WHEREAS, the City previously adopted the Leadville and Lake County Comprehensive Emergency Operations Plan (“Emergency Plan”) via Resolution No. 31, Series 2018; and

WHEREAS, the Emergency Plan is an emergency preparedness plan that sets forth the emergency obligations of the County and City governments and their capability and capacity to undertake emergency assignments or acquire those resources necessary to support its emergency mission; and

WHEREAS, due to the COVID-19 public health emergency, the City and Lake County have cooperatively developed the Lake County & City of Leadville Coronavirus (COVID-19) Response Plan (“COVID-19 Response Plan”) to lessen the impact and spread of COVID-19, protect the public health and welfare, and maintain government operations to serve the public during the course of the pandemic; and

WHEREAS, the COVID-19 Response Plan is a direct supporting document of the Emergency Plan; and

WHEREAS, the City Council desires to approve and implement the COVID-19 Response Plan and finds such action is in the best interest of the public health, safety and welfare.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado as follows:

Section 1. Recitals Incorporated. The above recitals are hereby incorporated into this Resolution as if fully set forth below.


Section 2. Approval of COVID-19 Response Plan. The City Council hereby approves the COVID-19 Response Plan, attached hereto as **Exhibit A**, to be implemented by the City in coordination with Lake County. The City Council further declares its commitment to cooperate with Lake County in the implementation and operation of the COVID-19 Response Plan.

Section 3. Effective Date. This Resolution shall take effect upon its adoption by the City Council.
