A RESOLUTION APPROVING A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF LEADVILLE AND RG AND ASSOCIATES, LLC FOR ON-CALL PLANNING AND ENGINEERING SERVICES

- WHEREAS, the City of Leadville ("City") is authorized under C.R.S. § 31-15-101 to enter into contracts for any lawful municipal purpose; and
- WHEREAS, the City issued a request for qualifications for on-call planning and engineering services on or about December 16, 2019 ("RFQ"); and
- WHEREAS, the City's selection committee and Planning and Zoning Commission have evaluated the proposals timely received together with the criteria set forth in the RFQ to determine the most qualified proposer; and
- WHEREAS, it is the desire and intent of the City Council to award the professional services agreement to the most qualified proposer who submitted qualifications in compliance with the requirements of the RFQ; and
- WHEREAS, the City Council, after full consideration of the proposals submitted and the recommendation of the selection committee and Planning and Zoning Commission, finds that RG and Associates, LLC ("Contractor") is the most qualified proposer; and
- WHEREAS, it is in the best interests of the City to award the professional services agreement for on-call planning and engineering services ("Services") to Contractor in the not-to-exceed amount of twenty thousand dollars and no cents (\$20,000.00); and
- WHEREAS, the City desires to enter into a professional services agreement with Contractor to have the Contractor perform the Services for the benefit of the City of Leadville ("Agreement").
- NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado as follows:
- **Section 1.** Recitals Incorporated. The recitals contained above are incorporated herein by reference and are adopted as findings and determinations of the City Council.
- Section 2. Award of Agreement. The City Council hereby: (a) awards the Agreement to the Contractor in substantially the form attached hereto as **Exhibit 1** in the not-to-exceed amount of twenty thousand dollars and no cents (\$20,000.00); (b) authorizes the City Attorney to make

such changes as may be needed to correct any non-material errors or language or to negotiate such changes to the Agreement as may be necessary and appropriate and that do not substantially increase the obligations of the City; and (c) authorizes the Mayor to execute the Agreement on behalf of the City once in final form.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
