A RESOLUTION AMENDING RESOLUTION NO. 20, SERIES OF 2021 SUPPORTING THE GRANT APPLICATION FOR A MAIN STREET: OPEN FOR BUSINESS GRANT FROM THE DEPARTMENT OF LOCAL AFFIARS

WHEREAS, City Council adopted Resolution No. 20, Series of 2021 ("Resolution 20") at its regular meeting on August 17, 2021; and

WHEREAS, Resolution 20 was adopted in support of the City's application for a Main Street: Open for Business ("MSOB") Grant from the Department of Local Affairs ("DOLA") to provide local business and property owners, including vacant properties, in the traditional downtown district funding to make energy efficient and façade improvements and to delegate authority to the appropriate persons to administer the MSOB Grants if the City's application is approved; and

WHEREAS, City Council desires to amend Resolution 20 to reflect the actual MSOB Grant award amounts that will be provided to one or more Leadville businesses.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leadville, Colorado as follows:

- **Section 1.** The foregoing recitals are incorporated herein by reference as findings and determinations of City Council.
- <u>Section 2.</u> The City Council of the City of Leadville hereby amends Resolution 20 such that its fourth recital is deleted and replaced with the following language to read in full as follows:
- WHEREAS, although individual projects typically will not exceed one hundred fifty thousand dollars (\$150,000.00) and require a twenty percent (20%) match, some individual projects may receive more than one hundred fifty thousand dollars (\$150,000), including one local project (The Herald Democrat building) which is anticipated to receive up to two hundred fifty thousand dollars (\$250,000).
- <u>Section 3.</u> <u>Original Terms and Conditions.</u> Except as amended herein, the original terms and conditions of Resolution 20 remain in full force and effect.
- <u>Section 4.</u> <u>Severability.</u> If any part, section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.
