### CITY OF LEADVILLE, COLORADO RESOLUTION 09 Series of 2020

A RESOLUTION ADOPTING FEES FOR PROCESSING LIQUOR LICENSE APPLICATIONS, MARIUJANA LICENSING, ADMINISTRATIVE AND ZONING FEES, POLICE DEPARTMENT FEES, SHORT-TERM RENTAL LICENSING, BUSINESS LICENSING, EXCAVATION PERMIT FEES AND ENCROACHMENT PERMITS

WHEREAS, the Leadville City Council hereby determines that the fees established by this Resolution are reasonable and are below or directly proportional to the actual and necessary expenses incurred by the City in processing the specified liquor license applications, marijuana licensing applications, administrative and zoning applications, police department application fees, short-term rental license applications, business license applications, excavation permit applications and encroachment permit applications.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEADVILLE, COLORADO as follows:

<u>Section 1</u>. The City Council hereby adopts the application fees for processing license applications as set forth in the attached Exhibit(s) A-E.

<u>Section 2</u>. The applicable fee(s) shall be paid in full to the City of Leadville at the time the application is submitted.

<u>Section 3</u>. <u>Severability</u>. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining issues of this Resolution.

Section 4. This Resolution shall be effective upon adoption.
